SUBJECT: Community Investments Overview and Allocation Recommendations

During the FY 2020-21 budget adoption, the Mayor and City Council approved a resolution to form a citizen-led Community Investments Review Committee (CIRC) to consider and make recommendations for additional City investments in addressing the conditions which contribute to poverty and hardship in our community. The Committee was appointed by the Mayor with two at-large City representatives and two representatives recommended by each of the eight City Council members. The 18-member Committee was asked to make recommendations for a proposed equity package of up to \$1 million total expenditures by October 2020.

The CIRC voted to recommend five funding categories:

- Grants for Social Justice/Anti-poverty Initiatives (\$200,000)
- Long-term Anti-poverty/Social Justice Strategies (\$200,000)
- Broadband Internet Access Expansion and Training (\$300,000)
- Heritage Preservation and Education (\$190,000)
- Mentorship and Neighborhood Capacity Building (\$110,000)

On Tuesday, November 17, 2020, the final recommendations of the Community Investments Review Committee (CIRC) were presented at a Special Meeting of the City Council. During this special meeting, the Council directed staff to move forward with Phase 2 of the process which offered an opportunity for non-profit organizations to apply for social justice and anti-poverty funding within four of the five categories established by the Community Investments Review Committee. The Broadband Internet Access Expansion and Training will be managed



in-house. Applications were made available December 10th and were due on January 15th at 5:00 p.m. There were 118 applications submitted for community investments funds. The submitted applications can be viewed at this link: https://www.cityofws.org/2837/CIRC-RF.

The Citizens' Bond Oversight Committee (CBOC) was commissioned to review and score the submitted applications. Agencies could receive a maximum score of 16 points.

CBOC used the following criteria to score the applications:

- The organization clearly states how they can address social justice or poverty issues.
- The program can be implemented quickly and will provide meaningful outcomes.
- The organization is successful (current or past) in addressing social justice or poverty issues.
- The organization is a trusted resource in the community.

CBOC used the combined average scores (including staff scores) as a guide to allocate funding within each funding category. For most categories, the committee allocated funding among agencies scoring 10 or higher, unless the committee thought that the agency could raise funding outside of this process for their proposed program. There were a couple of agencies scoring below a 10 that were considered due to the unique population that they served or the potential impact the agency could make in addressing social justice.

On Wednesday, February 24, 2021, the CBOC voted to recommend funding for a slate of non-profit and faith-based organizations. Exhibit A lists the recommended grant awards within each funding category. The exhibit includes the operating budget for each organization, their request, the combined average score (including staff), and the recommended grant award. Exhibit B lists those organizations that were not recommended for funding.
