Making the Case: High-quality Pre-K <u>IS</u> Crime Prevention

Short Term

- Fewer behavior problems in school career
- Reduction in grade retention and special education
- Fewer delinquency issues and reduced high school drop out rate

Long Term

- Better school outcomes leading to opportunities and stability after graduation
- Children attending preschool are less likely to develop alcohol or drug problems, commit a felony, and go to prison. They are half as likely to be arrested.

Overall Economic Benefits

- For every \$1 spent on high-quality preschool for 3- and 4-yearolds, communities save \$7 in long-term costs for things like educational remediation, social supports, or criminal justice.
- Quality preschool returned an average "profit" to society of \$15,000 for every child served, by cutting crime and the cost of incarceration, and reducing other costs

Forsyth County ARPA Funding

Why: Establish a High-Quality Pre-K Foundation

High-quality services and supports for the model cohort of 30 classrooms that includes 540 children and their families, 60 teachers, and various sites across the Pre-K landscape



Forsyth County ARPA Funding

Where: Mix within the current Pre-K Landscape

- 4 Winston-Salem/ Forsyth County classrooms
- 4 Head Start Classrooms
- 8 NC Pre-K classrooms in the community
- 14 private/independent classrooms in the community



Forsyth County ARPA Funding

How: Implement Recommendations of the ECE Task Force & Pre-K Priority

- Maximize strengths & synergize efforts
- Reduce duplication
- Identify & address gaps, set standards
- Create realistic roadmap for expansion
- Equity focus on inputs & outcomes
- Address disproportionately impacted children and families
- Intentionality and inclusion of families


