



**RESOLUTION AWARDING CONTRACT FOR 2-WAY RADIOS AND CONSOLES**

A motion was made by Board Member Dr. Jack Fleeer and seconded by Board Member Mrs. Lanette Allendorf for the adoption of the following resolution, and upon being put to a vote was duly adopted.

**WHEREAS**, Winston-Salem Transit Authority (WSTA) operates under the direction and authority of the Winston-Salem Transit Authority Board of Directors; and

**WHEREAS**, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 11:00 AM noon, on the 15<sup>th</sup> day of October, 2020 for 2-way radios, consoles and installation, and the following bids were received:

**WHEREAS**, add alternate no. 1 is 5-year warranty,

**WHEREAS**, it is the recommendation of the General Manager and the Purchasing Director that the add alternates be accepted and a contract be awarded to Mobile Communications, Inc.

The low bidder meeting specifications, in the amount of \$428,078.14.

**NOW, THEREFORE, BE IT RESOLVED**, by the Winston-Salem Transit Authority, an agency of the City of Winston-Salem, that the contract for 2-way radios, consoles and installation is hereby awarded to Mobile Communications, Inc. in the amount of \$428,078.14, and that all other bids are rejected and that the Chairman and Secretary are hereby authorized to execute the contract on behalf of the Authority, contract forms to be approved by the City Attorney and bid deposit retained until the successful bidder has provided satisfactory contract performance and labor and materials payment bonds.
