## **Summary of Information:**

At the request of Mayor Pro Tempore Adams, \$1 million is requested to assist residents within the one-mile radius of the Winston Weaver Company fire which is in the North Ward.

The City will contract with a non-profit (with City Council approval) ideally within the target area to distribute funding to residents based on need (i.e., hotel reimbursement or lost wages).

The amendment appropriates \$1,000,000 in general fund balance with the expenditure to be administered via a contract with a community agency. Undistributed funding will be transferred back to the General Fund.

**Remarks:** 

A qualified non-profit will be selected to disburse the proposed relief funding of up to \$1 million to assist low- to moderate-income residents who were strongly encouraged to evacuate their homes due to the Winston Weaver Fertilizer Plant fire on January 31, 2022.

#### **Recommended Agency:**

ESR (Experiment in Self-Reliance)

- ESR has served the low to moderate income population of Winston-Salem for over 55 years.
- ESR is in the North Ward and in close proximity to the target area.
- ESR assists clients with COVID relief funding, so eligible applicants for the City's Fire Relief Funds could also qualify for additional resources (i.e., rent/utility bill assistance, etc.).
- ESR requires an 18% administrative fee (standard % for grant funding) to manage the disbursement of funds.

#### Eligibility criteria for City's Weaver Fire Relief Fund:

The applicant for assistance on a reimbursement bases must be a city resident who is low to moderate income and must live within the evacuation area (one-mile radius of the Weaver Fertilizer Company) or work for a business located within the evacuated area that closed as a result of the voluntary evacuation request.

# **Type of Assistance:**

- Reimbursement for hotels expenses (maximum of 3 days). Hotel receipt is required.
- Lost wages (for low to moderate income/hourly wages only). Must work within the one-mile radius of the Weaver fire and be a resident of Winston-Salem)
- Other verifiable expenses directly related to the evacuation of this fire event.

#### **Reimbursement Amount:**

Reimbursement of expenses shall not exceed more than \$1,000 per household.

The amendment appropriates \$1,000,000 in general fund balance. Undistributed funding will be transferred back to the General Fund. Staff will seek reimbursement of funds from Weaver Company.
