Summary of Information:

Bids were received May 24, 2018, for the purchase of 62 golf carts intended as replacements for the fleet of Yamaha golf carts currently in use at Winston Lake Golf Course. The bid which required pricing for 62 new golf carts per detailed specifications also included a trade-in allowance for the current golf carts used by the facility which are 2013 Yamaha golf carts model #YDREL1H. These units would become surplus to the needs of the City. The City also requested alternate pricing from each bidder for built-in USB charging ports in each cart and a GPS system on each cart that will allow Winston Lake staff to track each cart's location on the course at all times. See Exhibit A for the detailed bid tabulation. See below for a summary of base bids received:

The City has the desire to purchase alternate 2, GPS tracking system, at the additional cost of \$47,616.00; therefore, it is recommended that a purchase order be awarded to EZ-GO, Division of Textron, Inc., low bidder meeting specifications, for the purchase of 62 EZ-GO TXT golf carts per bid specifications in the amount of \$151,900, which includes the trade-in allowance of \$96,100 for the 62 Yamaha golf carts currently in use at Winston Lake and an additional \$47,616 for the GPS tracking systems to be included in each cart for a total award amount of \$199,516.

This recommendation is in accordance with N.C.G.S 143-129.7, which provides "...the awarding authority may award a contract for both the purchase of the apparatus, supplies, materials, or equipment and the sale of trade-in property taking into consideration the amount offered on the trade-in when applying the criteria for award..."

The purchase of this equipment will be financed through the North Carolina Municipal Leasing Corporation. Funding for the lease payments is subject to appropriation in the General Fund FY 2018-19 budget.
