The estimated cost to make repairs to needed to render this dwelling fit for human habitation is **less than fifty percent (<50%)** of the present value of the dwelling.

Estimated cost to repair <u>\$1,242.00</u> Fair market value <u>\$13,050.00</u> Based on the above information it is recommended that an Ordinance be adopted to cause this dwelling to be <u>repaired or demolished and removed within ninety (90) days.</u> This structure can be repaired under In Rem provisions of the Minimum Housing Code with City Council approval.
