## **DUE PROCESS**

- 1. The current <u>Complaint and Notice of Hearing</u> was issued <u>08/11/2014</u> and service was obtained by certified mail <u>x</u> regular <u>x</u> post <u>x</u> hand delivery\_\_, and publication\_\_\_\_\_ on <u>08/21/2014</u>. The Hearing was held on <u>9/11/2014</u> and the owner/agent appeared and/or contacted the Community and Business Development Department regarding the complaint yes <u>X</u> no\_\_\_\_.

## **COUNCIL CONSIDERATION**

The estimated cost to make repairs to needed to render this dwelling fit for human habitation is **less than fifty percent (<50%)** of the present value of the dwelling.
