Summary of Information

The Winston-Salem Police Department has identified ongoing concerns related to juvenile victimization, large youth gatherings, disorderly conduct, and criminal activity occurring during late-night hours. Similar youth protection ordinances have been adopted by municipalities throughout North Carolina and across the nation as part of broader strategies to enhance public safety, reduce juvenile crime, and promote youth accountability.

The proposed Youth Protection Ordinance would establish a curfew for individuals under the age of 18 within public places and businesses throughout the City of Winston-Salem between the hours of 10:00 p.m. and 6:00 a.m. The ordinance includes reasonable exemptions for juveniles engaged in employment, school-sponsored activities, religious events, emergencies, and circumstances in which the juvenile is accompanied by a parent, guardian, or other responsible adult authorized by the parent or guardian.

The Winston-Salem Police Department is asking for the adoption of a Youth Protection Ordinance to establish curfew hours for juveniles, under the age of 18, during the hours of 10:00 p.m. to 6:00 a.m. at public places and businesses within the City and provide law enforcement with an additional tool to enhance public safety, reduce juvenile victimization, and address youth-related crime.
