Background

- •11-member commission created by Mayor Joines and Members of NCGA
- Created after the filing of House Bill 519
- Diverse group of residents and business owners
 - 45% female
 - 45% African American
- Official charge:
 - Review governance structure and representation models
 - Be mindful of not diminishing minority representation
 - Take into account geographic representation

- Information on charter changes in other NC cities
- National League of Cities information on at-large v. district representation
- Elections and demographic information


Public Input Sessions

- •Three public input sessions held last week of January 2020
 - Carver High School
 - Easton Elementary
 - South Fork Elementary
- Estimated 25-50 participants per meeting
- •Format included:
 - Video presentation
 - Information boards
 - Interaction with Commission Members and City staff

Public Input Survey

- Seven-question survey
 - All questions had only two or three response options
 - Response areas for narrative comments
- Non-random sample
 - Not statistically significant
 - Cannot be generalized to total population
 - Response bias self selection
 - Possibility for non-unique responses
- •921 total responses
- Six of nine City elected officials responded
 - Separate version of the survey





Public Input Survey Results

- •57% responded there should be more at-large representation
 - 57% 8/2 split, 28% 5/3 split, 14% 6/2 split
- •72% responded in favor of four-year terms
- •59% responded in favor of staggered terms
- •76% responded in favor of even-year elections
- •60% responded in favor of partisan elections
- •66% responded in favor of the mayor only voting to break a tie
- •97% responded in favor of the mayor being elected by the voters

Recommendations

Only Item Recommended for Change to Current Structure:

- More at-large representation on City Council
- Recommended to add two additional seats to current structure

For all other items, votes were taken to recommend maintaining current structures
