CITY MANAGER UPDATE

The City Manager shared several updates on recent city initiatives and community activities. The city continues coordinating bulky item pickups to assist residents and maintain neighborhood cleanliness. Staff also updated the GIS maps, including filtering by wards and current locations of affordable housing projects. The Sustainability Department is promoting “No Mow March,” encouraging residents to delay mowing during March to support pollinators and biodiversity. Additionally, 23 Winston-Salem police officers graduated from the police academy and will begin serving the community. During Community Roots Day, volunteers planted 110 Mulberry trees at Kimberly Park, helping support environmental sustainability.
