The undersigned respectfully petitions the Honorable Mayor and City Council of the City

of Winston-Salem as follows:

I.

Your petitioner declares that he is the owner of 4900, 4971 and 4972 Millenium Drive, Winston-Salem, NC 27107 and that as to other property abutting the portion of Millenium Drive which he wants to have closed and abandoned, the following are the owners:

Please state your reason / purpose for closing a portion of said street / alleyway

In accordance with the attached proposed plat to be recorded by the petitioner as owner of the abutting properties, the petitioner intends to extend the Millenium Drive as shown on the plat and abaondon the 2 small sections of the street outside of the extended proposed right of way described as "Right of Way To Be Abondoned", as shown on the proposed plat attached hereto as Exhibit A.

Said portion of Millenium Drive was dedicated to public use upon the public records appearing in the Office of the Register of Deeds of Forsyth County, North Carolina. Its use as a street or public way is unnecessary for the normal flow of traffic through the surrounding area.

Your petitioner respectfully petitions that the following described portion of said Millenium Drive officially be closed and abandoned:

COMMENCING FROM A 1" IRON PIPE FOUND IN THE EASTERN RIGHT OF WAY OF MILLENNIUM DRIVE (60' PUBLIC R/W), HAVING NC GRID COORDINATES OF N:842,664.73, E:1,665,174.74, AND BEING THE NORTHWESTERN CORNER OF THE UCIC-II LLC PARCEL AS DESCRIBED IN DEED BOOK 3407, PAGE 2304, FORSYTH COUNTY REGISTRY AND AS SHOWN ON PLAT BOOK 68, PAGE 11, FORSYTH COUNTY REGISTRY; THENCE ALONG SAID EASTERN RIGHT OF WAY OF MILLENNIUM DRIVE, N 13°34'34" W A DISTANCE OF 98.05 FEET TO A POINT; THENCE S 76°25'26" W 60.00' TO A POINT, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE FROM THE TRUE POINT OF BEGINNING AND ALONG SAID WESTERN RIGHT OF WAY OF MILLENNIUM DRIVE THE FOLLOWING THREE (3) COURSES: 1) S 76°25'26" W A DISTANCE OF 15.00 FEET TO A POINT; THENCE 2) N 13°34'34" W A DISTANCE OF 55.00 FEET TO A POINT; THENCE 3) N 76°25'26" E A DISTANCE OF 15.00 FEET TO A POINT; THENCE A NEW LINE ACROSS THE WESTERN PORTION OF SAID WESTERN RIGHT OF WAY OF MILLENNIUM DRIVE, S 13°34'34" E A DISTANCE OF 55.00 FEET TO THE TRUE POINT OF BEGINNING CONTAINING 825 S.F.

III.

No individual owning property in the vicinity of the aforesaid portion of Millenium Drive will be deprived of reasonable means of ingress to and from his property, nor is the closing thereof contrary to the public interest.

WHEREFORE, your petitioner respectfully requests the City of Winston-Salem, acting through its City Council to close and abandon for street purposes that portion of said Millenium Drive described, all as provided by law, particularly by Section 160A-299 of the General Statutes of North Carolina.
