Summary of Information:

The City of Winston-Salem accepted and received \$51.7 million through the American Rescue Plan Act's (ARPA) Coronavirus Local Fiscal Recovery Fund (CLFRF) from the U.S. Department of the Treasury. On January 3, 2023, the City Council approved using the revenue replacement method for about \$49 million of the total funds; herein ARPA-Enabled Funds.

These ARPA-Enabled Funds provided for the \$10.5 million in Transformational Grants. Fifteen community organizations were awarded funds:

- Arts Council of Winston-Salem and Forsyth County There's No Place Like Home
- Boston Thurmond Community Network United Initiative
- Old Salem Museum and Gardens Reopening
- The Salvation Army of Greater Winston-Salem and Forsyth County Teen Center
- YMCA of Northwest North Carolina REACH Center

These ARPA-Enabled Funds also provided funding for \$1,760,000 in Housing Transformational Grants—funded specifically under the Housing Assistance bucket of funds—on November 14, 2022 to four community agencies:

- Boston-Thurmond Community Network Land Acquisition and Development
- Christ Rescue Temple Apostolic Church Christ Rescue Temple Systems Apartments
- S.G. Atkins Community Development Corporation Salem Cohousing Project
- Whole Man Ministries Housing 4 Our Heroes

Due to the expressed need and challenges of several of these nonprofit agencies, City Management sees the need to provide the grantees an avenue for getting projects initiated effectively through a start-up lump sum of funding/working capital.

This amended item clarifies the authority granted to the City Manager in the October 17, 2022; November 14, 2022; and January 3, 2023 resolutions ("to execute individual contracts with each of the aforementioned organizations based on the scope of work, listed as a part of the Resolution Attachment, received, and discussed as a part of the Transformational Grants program" and "to review and approval final terms and conditions. . . and execute contracts and documents necessary") and ratifies the June 22, 2023 Memo to City Council and actions taken by City Management in accordance with such ("to use [the City Manager's] discretion to offer City Council-approved Transformational Grant and Housing Transformational grantees that have expressed start-up capital needs an amount not exceeding 25 percent of the grantee's total award. After expending the initial start-up funds, the nonprofit must provide adequate documentation of expenditure of eligible cost items before moving to a monthly reimbursement basis for the remaining award balance."). Further, this item authorizes City Management to amend agreements to reflect such.
