- A. The rezoning application has been submitted to the City and will be heard by the Planning Board at their meeting on December 9; the rezoning request should be heard by the City Council at the first council meeting in January.
- B. The request is to rezone from MU-S to PB-S. The purpose of the request is to allow occupation of the property by the Carolina's Vineyards and Hops business. A summary of the proposed use of the building and grounds was provided. These uses will include the sale of wine and beer, micro-brewery and distillery, a restaurant, urban vineyards, retail store, outdoor events, special events center and hotel/motel (air bnb type use).
- C. The existing building will remain and be remodeled and improved.
- D. The proposed tentative outside landscape and hardscape improvements were identified.
- E. Attendees expressed concerns about security from and the use of the adjacent property on the corner.
- F. Attendees generally seemed pleased that the property will be improved and redeveloped and expressed no real concerns about or opposition to the rezoning request.


