Resolution Approving a Contract with NWN Corporation for the Purchase of Wireless Network Equipment

Summary of Information:

The Information Systems Department maintains 114 wireless network access points that are installed at The Carolina Classic Fairgrounds and The Benton Convention Center. The network access points at these locations enable secure wireless communication and Wi-Fi internet access for visitors and staff at these facilities. The existing network access points have reached end-of-life and are no longer supported by the manufacturer. Staff recommends replacing these aging devices with next-generation wireless network equipment that will provide better performance and reliability, improved compatibility with modern mobile devices, and seamless integration with the existing Cisco cybersecurity infrastructure.

Using specifications provided by Information Systems staff, the Purchasing staff advertised an Invitation for Bid (IFB) for wireless network equipment. Responses were received from eight vendors, with the lowest quote provided by NWN Corporation.
