Dear Marc:

Winston-Salem/Forsyth County Utilities has requested a site plan amendment to accommodate the proposed construction of a Mechanically Stabilized Earthen (MSE) Berm at Hanes Mill Road Landfill. This amendment (case #W-3539) is scheduled for the August 11 meeting of the City-County Planning Board.

This letter is intended to document outreach and educational efforts related to this project. On July 6, 2022, flyers were mailed to surrounding property owners providing notice of an informational Neighborhood Meeting scheduled for July 14, 2022 at the Hanes Mill Road Landfill. A copy of the flyer is provided in **Attachment A**. The flyer was bilingual, with English on one side and Spanish on the other. The flyer also provided contact information for City Link should more information about the proposed project be requested by the recipient.

Flyers were mailed to 36 parcels located within a 500-foot radius of the landfill's current General Industrial zoning boundary (as shown on the proposed site plan). Flyers were also mailed to owners of 79 additional property parcels located beyond the 500-foot radius of the zoning boundary. In total, flyers were sent to 96 owners of the total 115 property parcels (some of the owners own multiple property parcels). A map of the parcels, list of associated owners and delivery tracking information are provided in **Attachment B**.

The Neighborhood Meeting was held on July 14, 2022 from 5:30 pm to 6:30 pm at the Hanes Mill Road Landfill Administration Building. Four informational stations with visual posterboards were set up in the meeting space to help facilitate conversation and explain project details. Additionally, copies of a detailed project handout sheet were given to attendees as take-home reference material. Electronic versions of the posterboards and handout, as well as a description of the meeting, are provided in **Attachment C**. Photographs taken at the Neighborhood Meeting are provided in **Attachment D**.

All twelve (12) attendees at the meeting were given City-issued comment cards and contact information, should they desire to provide feedback at a later time. As of August 3, 2022, no additional public comments on this project (other than those received in-person at the Neighborhood Meeting) have been received through City Link, phone, email, comment cards or other means.

Four (4) Winston-Salem/Forsyth County Utility Solid Waste Department representatives, two (2) engineer consultants, one (1) third-party public outreach coordinator, and one (1) landfill staff member capable of interpreting and speaking Spanish were present and helped facilitate the Neighborhood Meeting held at the Hanes Mill Road Landfill on July 14, 2022.

Twelve (12) public individuals attended the Neighborhood Meeting. Of the 12 individuals, ten (10) were residents/owners representing seven (7) households and one (1) multi-parcel development project. The remaining two (2) individuals were one (1) Winston-Salem/Forsyth County Utility Commission member and one (1) Council liaison of Mayor Pro Tempore Denise Adams of the North Ward.

The majority of public comment and feedback regarding the project were not necessarily concerns, but general inquiries about the project. Issues discussed included, but were not limited to, what the berm would be made of; how the berm would be constructed; if water impacts are anticipated; what the new expected landfill life is; how long construction of the berm would take; and other future development plans that could cause a horizontal expansion of the landfill.

The only concerns/complaints received were from two (2) residents of the same single household. The residents live in the neighborhood located to the northwest of the landfill. The residents indicated that they had lived there before the landfill expansion unit was constructed, and voiced their dissatisfaction with a landfill being developed during the public meetings for that approval process (around 1999-2000). Their questions and comments indicated their dissatisfaction with the existence of the landfill in its current location. Staff and consultants discussed the project with them, made them aware of landfill life projections, and a landfill supervisor provided his direct contact information should they have future questions or complaints.



As of August 3, 2022, no additional public comments on this project (other than those received in-person at the Neighborhood Meeting) have been received through City Link, phone, email, comment cards or other means.




