Resolution Awarding Contract for Asphalt Crack Sealing Services

Summary of Information:

The City of Winston-Salem has the need for a contractor to seal pavement cracks to prolong the life of city streets. The crack seal product is a type 3 asphalt rubber applied using a pressure feed melter after the cracks to be filled are prepared with a 2,000-degree minimum hot air lance system. This work is performed during the fall and winter months.

City/County Purchasing issued a Request for Proposals (RFP) to provide Asphalt Crack Sealing Services, with proposals received on October 19, 2022, from the following firms: Deep South Industrial Services, Inc., located in Rockmart, GA, Delta Contracting, Inc., located in Haw River, NC, Gordon Company, Inc. located in Thomasville, NC, Remac, Inc. dba Remac Asphalt Maintenance, Inc. located in Freeman, VA and Slurry Pavers, Inc. located in Richmond, VA.

Terms of the bid document specified detailed evaluation criteria of business location, cost effectiveness/price value and reference list providing similar services within the past five years. An evaluation panel of staff members from Traffic Field Operations, Engineering, and Business Inclusion and Advancement reviewed the proposals received. See Exhibit B for the detailed scores.

Based upon the evaluation panel's assessment, it is recommended that a contract for Asphalt Crack Sealing Services per the prices offered in the RFP be awarded to Delta Contracting, Inc., in the annual amount of \$79,200. Terms of the bid allow for the possibility of two annual extensions, (until December 31, 2025), if both parties agree and funds are made available for that purpose. Making the total possible award amount over three years in the estimated amount of \$237,600.
