## **Council Action Requested**:

Resolution Authorizing a Contribution of \$350,000 to Smart Start of Forsyth County for Pre-K Initiatives

## **Summary of Information**:

As part of the FY 21-22 budget, the Mayor and City Council appropriated \$1.35 million to fund several crime prevention initiatives, including \$350,000 for Pre-K initiatives. In September 2021, the Mayor and City Council approved the use of American Rescue Plan Act funds for the crime prevention plan. Earlier in March 2021, the Mayor and City Council, in coordination with the Forsyth County Board of Commissioners and the Winston-Salem/Forsyth County Schools Board of Education, approved a resolution to form the Early Childhood Education Task Force (Task Force) to lead the community in developing a plan to ensure that all of Forsyth County's children have access to high-quality Pre-K programs. The Pre-K Priority, a coalition that was formed in 2014 by a group of early childhood professionals to explore how to improve the quality and number of Pre-K programs in Forsyth County, coordinated the work of the Task Force. The 32-member Task Force began meeting in June 2021 and presented their recommendations in November 2022.

With an initial focus on improving the quality of Pre-K programs in Forsyth County, the Pre-K Priority coalition has developed a proposal to deliver a two-year cohort project with specific high-quality resources and supports that currently are limited or non-existent. The project will

include thirty Pre-K classrooms across the following sites: four WS/FCS classrooms, four Head Start classrooms, eight North Carolina Pre-K classrooms in community sites, and 14 private/independent classrooms. The project will impact 540 Pre-K students and their families, as well as 60 Pre-K educators.

In June, Smart Start of Forsyth County applied for Forsyth County ARPA funding totaling \$3,826,406 on behalf of the Pre-K Priority to fund the two-year cohort project. The County Board of Commissioners awarded \$3.7 million to Smart Start of Forsyth County, resulting in a shortfall of \$126,406.

Pre-K Priority staff have worked with City staff over the last several weeks to develop a proposal for utilizing the City's appropriation of \$350,000 for Pre-K initiatives. The following table outlines the Pre-K Priority's proposal.

On January 3, 2023, the City Council awarded two transformational grants under the City's ARPA framework that would support other childcare initiatives: (1) Imprints Care's Family Resource Center for Children with Exceptional Needs (\$500,000) and (2) Smart Start of Forsyth County's Winston-Salem Childcare COVID-19 Relief Fund (\$660,000). Imprints Care's proposal would support their expanded learning program, services offered in the first Family Resource Center for Students with Exceptional Needs in Winston-Salem, and Ready for School (prenatal – age 5) programs. Smart Start of Forsyth County's COVID-19 Relief Fund would focus on the opening and maintenance of closed, licensed family childcare facilities. The fund would provide for Early Childhood Coaches, a Wonderschool online platform to support enrollment and marketing, and a 12-week business support program that would include retention bonuses for teachers. These two initiatives complement, but do not overlap, the two-year cohort

project that the City would fund through the crime prevention plan. The Pre-K Priority's project would focus on enhancing the <u>quality</u> of existing Pre-K programs in Forsyth County.

At the Community Development/Housing/General Government Committee's December 2022 meeting, Pre-K Priority staff presented more detailed information about their proposed use of City funds for their initiatives. The staff also has provided the attached responses to questions from the committee's discussion of the proposal.

The attached resolution authorizes the City to enter into an agreement under G.S. 160A-209 and G.S. 160D-1311 to contribute \$350,000 to Smart Start of Forsyth County, which will serve as the administering agency for these funds. The agreement will establish metrics and reporting requirements to track the outcomes achieved with the City's funding.
