Why are you interested in serving on that Board/Commission?	<p>I have a deep interest in the role of food systems in reducing food insecurity. I have volunteered in food recovery and redistribution since 2009 and have worked full time to run a collegiate food recovery program since 2016. I have served as a Summer Food Service Program (SFSP) sponsor since 2017 and co-founded a cooking and nutritional education program for children in 2018. All of this work has been in Winston-Salem. The work of the Urban Food Policy Council is vital to the continued growth of local agriculture and supporting our community, which has a high rate of food insecurity. I have seen the successes of the UFPC since its founding and hope to contribute to future initiatives. Specifically, I would like to build off the work on breakfast in schools that the UFPC has focused on. The City of Winston Salem has a great opportunity to support the growing network of summer food providers to reach more children. Based on data from No Kid Hungry NC, Forsyth County met less than 15% of the identified need for summer meals in 2019. I feel this is a missed opportunity. The work of the Think Orange campaign is a great start and our city must continue to expand existing sites and promote the program to new sponsors. As a three time recipient of the SFSP Turnip the Beet nutrition award and the Rising Star</p>

award (2017), I bring a level of insight into how to make this effective in our city. More immediately, the COVID-19 crises has put pressure on our food system at all levels. It is important that the UFPC evaluate the on-going situation and identify barriers to growing food in our city. I was recently made aware that there have been concerns that the ordinance around chicken coops in the city is restrictive for lower income individuals. This is one example of a policy that the UFPC should consider promptly and make a recommendation to city council on the best solution. I am eager to contribute my time to this important cause.
