## NOTICE OF PUBLIC HEARING ON PROPOSED MULTIFAMILY HOUSING REVENUE BONDS FINANCING BY THE HOUSING AUTHORITY OF THE CITY OF WINSTON-SALEM

Notice is hereby given that a Hearing Officer of the Board of Commissioners of the Housing Authority of the City of Winston-Salem (the "Au-thority") will hold a public hearing on the Authority's proposed plan to issue its multifamily housing revenue bonds in an amount up to \$13,089,000 (the "Bonds") for the financing of the acquisition, rehabilitation and equipping by Winston Summit, LP, a North Carolina limited partnership, or an affiliated or related entity (the "Company"), of a qualified residential rental project (as defined in Section 142(d) of the Internal Revenue Code of 1986, as amended) for seniors known as Winston Summit Apartments (the "Development"). The Development consists of approximately 100 units located at 137 Columbine Drive in the City of Winston-Salem, Forsyth County, North Carolina. The Development will be owned or operated by the Company.

The housing bonds, when and if issued by the Authority, will be issued pursuant to Article 1 of Chapter 157 of the General Statutes of North Carolina and shall not be a debt of the State of North Carolina (the "State"), the Authority, the City of Winston-Salem, North Carolina (the "City") or any political subdivision thereof and none of the State, the Authority, the City or any political subdivision thereof shall be liable thereon, nor in any event shall such bonds be payable out of any funds or properties other than those of the Authority derived solely from payments made by the Company.

The public hearing, which may be continued or adjourned, will be held on March 29, 2023, at 10:00 a.m. (or as soon thereafter as the hearing is held) at 500 W. 4th Street, Suite 300, Winston-Salem, North Carolina 27101. Any person interested in the issuance of the Bonds or the Development may appear and be heard at the public hearing. Any person wishing to comment in writing on the Development or the issuance of the
