Resolution Awarding Purchase Orders for Twenty-One Dodge Durango Pursuit Vehicles

Summary of Information:

The Patrol Division of the Police Department budgeted for seventeen pursuit vehicles as replacements for vehicles that meet or exceed Fleet's criteria for replacement. See Exhibit A for replacement information.

In addition, the Fire Department's B.E.A.R. Team is requesting four vehicles for crisis counselors responding to mental health calls and to transport clients to facilities if deemed necessary. See exhibit A for complete replacement information on the seventeen vehicles intended for the Police Department.

The North Carolina Department of Administration, an agency of the state of North Carolina located in Raleigh, N.C. received bids for fleet vehicles and on May 10, 2021, Ilderton Dodge Chrysler Jeep Ram, LLC (High Point, NC) was awarded competitive bid contract #070A and has offered a quotation for seventeen 2023 Dodge Durango pursuit vehicles meeting WSPD specifications at \$41,292.80 each for a total cost of \$701,977.60. Ilderton Dodge Chrysler Jeep Ram LLC has also offered a quotation for four 2023 Dodge Durango pursuit vehicles meeting modified WSPD specifications at \$41,062.50 each for a total cost of \$164,250.00.

It is recommended that purchase orders be awarded to Ilderton Dodge Chrysler Jeep Ram, LLC for seventeen 2023 Dodge Durango pursuit vehicles at \$41,292.80 each for a total cost of \$701,977.60 and for four 2023 Dodge Durango pursuit vehicles at \$41,062.50 each for a total cost of \$164,250.00, making the total award the amount of \$866,227.60.
