- G-1. WINSTON-SALEM POLICE DEPARTMENT EMPLOYEE AND OFFICER OF THE YEAR FOR 2016.

Mr. Barry Rountree, Chief of Police, gave a presentation on employees of the year for the Police Department. Those recipients were Forensics Services Technician, Ashley Shumaker; Forensics Services Squad Supervisor, Phillip B. Seats and Officer M. W. Powell.

- G-2. PROPOSED *UNIFIED DEVELOPMENT ORDINANCES* TEXT AMENDMENT ADDING “NEEDLE AND HYPODERMIC SYRINGES EXCHANGE PROGRAM” AS A USE.

Mr. Jerry Kontos, Assistant City Attorney, gave the staff report on this item.

In response to Council Member MacIntosh, Mr. Kontos stated within Winston-Salem, the needle share program has one known location at the Green Street Church.

Mr. Colin Miller, 1039 Montgomery Street, stated he is a part of another local Needle Share organization located in Winston-Salem.

In response to Council Member MacIntosh, Mr. Kontos stated if this item passes as an ordinance, by right, as it is currently proposed, it would be allowed.

Council Member MacIntosh requested staff provide a list of locations where these programs would be the most use in.

Council Member Burke requested staff propose a special use process that may take care of the spacing issues.

By consensus, the Committee agreed to hold this item for the April meeting. The Committee also requested that staff bring back an ordinance for the Committee’s consideration in April.

Council Member MacIntosh requested staff provide documentation of what the impact would be to the neighborhoods if this program is present.

- G-3. UPDATE ON HANDICAP PARKING DOWNTOWN. *[Item continued from the November 2016, Community Development/Housing/General Government Committee.]*

Mr. Gregory Turner, Assistant City Manager, gave the staff presentation on this item. Council Member Larson requested a map of the designated locations for the handicap parking designated spaces and in the form of an ordinance.

By consensus, the Committee agreed to hold this item for discussion at April meeting.

Mrs. Nancy Dennis, 217 Tarbranch Court, spoke in support of the handicap parking.

Ms. Tiffany Howell, 1137 Fennimore Street, spoke on the lease coverage on Burke Street. She also stated she has a business on Burke Street and has employed City police officers and she feels she shouldn't be personally responsible for paying for those services.
