This memorandum is to provide additional information on the item.

Federal Funding

Committee members requested information on whether or not the federal funds for the grants listed in the item are threatened in any way. In collaboration with Strategics Consulting, staff confirms that the Federal Fiscal Year 2017 Consolidated Appropriations (omnibus) funding bill has been signed into law and will provide all FFY 2017 funding through September 30, 2017. The funds referenced in the item are included under the bill for FFY 2017.

Projects are funded on an annual basis. We anticipate bringing an item to City Council next year for new and renewal grants. The projects to be included in the application next year would be funded by Federal Fiscal Year 2018 appropriations. FFY 2018 funds have not been determined yet.

Agency Funding Levels

Committee members requested information on funding levels by agency. Attached Table 1 provides the breakout of funds by program type and agency.
