## **RESOLUTION APPROVING CONTRACT WITH NWN CORPORATION FOR CICSO WI-FI NETWORK EQUIPMENT FOR FIRE STATIONS**

WHEREAS, internet access for Fire personnel at the fire stations is provided through a minimum number of desktop devices and hard wired connections, resulting in resource limitations for staff when requiring internet access for administrative, planning, scheduling, and training activities; and

WHEREAS, Wi-Fi network availability in the stations will eliminate resource limitation issues and accommodate internet access for both City provided and personal devices via a secure and monitored network path; and

WHEREAS, increased availability to internet access will support a growing demand from staff as the City moves to cloud-based applications such as the new Records Management System and an increased use of the internet for various training activities, communications, and staff collaboration; and

**WHEREAS**, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 p.m., December 21, 2017, to provide the necessary Cisco equipment, to be installed by City staff, to support a Wi-Fi network in each fire station and the following bids were received:

WHEREAS, as with all new equipment, this Wi-Fi equipment should be added to the City's Cisco SmartNet maintenance agreement, currently held by NWN Corporation, for a cost of \$12,485.48; and

**WHEREAS,** approval is requested to enter into a contract with NWN Corporation for the Cisco Wi-Fi network equipment per bid specifications at the cost of \$107,419.75 and SmartNet maintenance at the cost of \$12,485.48 for the total award amount of \$119,905.23.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Winston-Salem that a contract for the Cisco Wi-Fi network equipment per bid specifications at the cost of \$107,419.75 and SmartNet maintenance at the cost of \$12,485.48 for the total award amount of \$119,905.23 is hereby awarded to NWN Corporation in the total bid amount of \$119,905.23 and that all other bids are rejected.

**BE IT FURTHER RESOLVED** that the award of this purchase constitutes a preliminary determination as to the qualification of the bidder. The City is not legally bound to perform the purchase until the contract is duly executed by the City.

**BE IT FURTHER RESOLVED** that the City Manager is hereby authorized to execute the contract on behalf of the City.

**BE IT FURTHER RESOLVED** funds are available for this purchase in the approved FY17-18 I.S. operating budget.
