Staff recommends exploring a better treatment/transition along Hundley- 3 stories vs 4, increased landscaping/berming; Provide pedestrian connection to Hundley; Will likely need more detail on streetscape along Meadowlark- i.e. what will the wall look like, planting strip width adjacent to sidewalk, etc; Unit calcs on plan don't match the legend; Staff recommends providing bufferyard/landscaping along western property line; Easements needed for any off-site grading; Staff recommends reducing the list of proposed uses to those that are residential/institutional in character.
