The community has been working with Captain Danny Watts on these issues and Captain Watts has been extremely cooperative as he can only ask them to turn motors off, he can't make them. Once the Police presence is no longer there, the motors are turned on again. Each neighbor in community would appreciate this issue being resolved as soon as possible for a better quality of life. We're asking that the zoning orders be changed to prohibit the idling motors and noises. Would like for Council to look into building a barrier sound wall which would eliminate noises.

This would help to not only increase ridership but decrease traffic and pollution, reduce accident fatalities; increase physical activity, increase access to health care and stimulate the economy as well.
