Historic Resources staff has reviewed the 5 properties that are scheduled to go before the Community Development/Housing/General Government Committee on March 12, 2019 for demolition consideration.

Local Historic Landmarks or Local Historic/Historic Overlay Districts

None of the buildings are Local Historic Landmarks or located within locally-designated historic districts.

National Register Historic Districts

1) 2303 Waughtown Street – Waughtown-Belview Historic District

The house at **2303 Waughtown Street**, known as the Vogler House, is a ca. 1890 two-story, I-house with two brick chimneys, battered columns on brick piers, and exposed rafter tails. The site also includes a rare – for the district – nineteenth century agricultural outbuilding. Both buildings are contributing structures to the Waughtown-Belview Historic District. If demolition for this structure is approved, Historic Resources staff requests that the Community Development Department have the structures professionally photo-documented and submit the photos to the Forsyth County Historic Resources Commission.

2) 828 Gray Avenue – Reynoldstown Historic District

The house at **828 Gray Avenue**, built in 1939, is a side-gable traditional minimal house. It is a contributing structure to the Reynoldstown Historic District. In 1939, RJR sold this lot to Hamilton & Bessie Stratford, an African-American couple, who were living here by 1940. If demolition for
