The Order directed the owner to <u>vacate and close or repair</u> the dwelling within <u>30</u> days from receipt. The time for compliance expired on <u>7/5/2018</u>. The dwelling was found vacated and closed on <u>8/25/2018</u>.

The notice further advised that if the owner(s) intended to request an extension of time, they should present evidence of their intent to the Community Development Director prior to the Committee meeting.
