AN ORDINANCE AMENDING THE WINSTON-SALEM CITY ZONING ORDINANCE AND THE OFFICIAL ZONING MAP OF THE CITY OF WINSTON-SALEM, N.C.

BE IT ORDAINED by the City Council of the City of Winston-Salem as follows:

Section 1. The Winston-Salem City Zoning Ordinance and the Official Zoning Map of the City of Winston-Salem, N.C. are hereby amended by changing from <u>IP</u> to <u>GB-S</u> (<u>Group Care</u> <u>Facility C</u>; <u>Child Care</u>, <u>Drop-In</u>; <u>Church or Religious Institution</u>, <u>Neighborhood</u>; <u>Golf Course</u>; <u>Government Offices</u>, <u>Neighborhood Organization</u>, <u>or Post Office</u>; <u>Habilitation Facility A</u>; <u>Habilitation Facility B</u>; <u>Habilitation Facility C</u>; <u>Library</u>, <u>Public</u>; <u>Museum or Art Gallery</u>; <u>Nursing</u> <u>Care Institution</u>; <u>Police or Fire Station</u>; <u>Recreation Facility</u>, <u>Public</u>; <u>Utilities</u>; <u>Academic</u> <u>Biomedical Research Facility</u>; <u>Adult Day Care Center</u>; <u>Child Care Institution</u>; <u>Child Care, Sick</u> <u>Children</u>; <u>Child Day Care Center</u>; <u>Church or Religious Institution</u>, <u>Community</u>; <u>Family Group</u> <u>Home B</u>; <u>Park and Shuttle Lot</u>; <u>School</u>, <u>Private</u>; <u>School</u>, <u>Public</u>; <u>School</u>, <u>Vocational or</u> <u>Professional</u>; <u>Club or Lodge</u>; <u>College or University</u>; <u>Family Group Home C</u>; <u>Recreation Services</u>, <u>Indoor</u>; <u>Recreation Services</u>, <u>Outdoor</u>; <u>Transmission Tower</u>; <u>Access Easement</u>, <u>Private Off-Site</u>; <u>and Animal Shelter</u>, <u>Public</u>) the zoning classification of the following described property:</u>

A portion of PIN 6828-13-9481 as shown on the site plan titled: "ARCA, Inc., 5580 Sturmer Park Circle, Winston-Salem, North Carolina;" sheet title "Rezoning Site Plan;" Sheet RZ-1; prepared by MLA Group, dated 2/5/2019, with last revision 3/6/19.

Section 2. This Ordinance is adopted after approval of the site plan entitled <u>Arca, Inc.</u> and identified as Attachment "A" of the Special Use District Permit issued by the City Council the 1^{st} day of <u>April</u>, 2019 to Forsyth County.

<u>Section 3</u>. The City Council hereby directs the issuance of a Special Use District Permit pursuant to the Zoning Ordinance of the *Unified Development Ordinances* for a development to be known as <u>Arca, Inc.</u>. Said Special Use District Permit and site plan with associated documents are attached hereto and incorporated herein.

<u>Section 4</u>. This Ordinance shall be effective from and after its adoption.
