Council Member Clark requested a report of how many substandard houses are in Winston-Salem. He voiced concerns regarding the effectiveness of this plan and noted that he observed the Happy Hill neighborhood and the quality of the houses built by Habitat. He stated if the City truly wants to address affordable housing and substandard housing, there needs to be a plan that cost less than \$65,000 per house. He challenged staff to work with the community to be creative with ideas to help with the issue. He said the City would never make a dent if it is only fixing 1% of the houses each year.

Council Member Adams stated the City is reviewing other avenues to bring remedies to this crises noting collaborating with the recently created NLC Task Force as well as Federal, State, and Non-Profit Organizations. She stated this is a national issue and invited everyone to attend the "Now What Do We Do" meeting on April 20th to further discuss ideas. Council Member Larson stated he liked the idea of reinvesting in older neighborhoods as well as expediting the turnaround time for projects that are underway.

Mayor Pro Tempore Burke shared the City has been struggling for years to help older neighborhoods and stated the need to shorten the turnaround time for projects that are underway.

Tasha Logan Ford, Assistant City Manager, stated a report has been provided regarding the number of homes completed in each Ward and noted that the Southeast Ward had the highest number of homes that were done. She stated if the public would like to see a home that has been renovated they could contact Community Development and they would provide the list. She explained a lot of the work that is done is interior work involving ceilings and some handicap accessibility issues such as access to the bathrooms. She stated with increasing the limits we could start to see more of the curb appeal items addressed.

Council Member MacIntosh pointed out that Winston-Salem is not alone in the lack of quality affordable housing noting the housing crises goes with poverty as much as everything else. He stated with the formation of Poverty Thought Force Commission it is a start in solving the poverty issue.

Mayor Pro Tempore Burke requested information regarding the number of residence that are still in some of the past houses that were renovated.

Mayor Joines concurred with Council Member MacIntosh and Council Member Adams regarding affordable housing being a nationwide issue and noted he is Chairing a group of North Carolina Mayors to help with the crises.
