The Dodge Journey bid from Horace G. Ilderton, LLC is offered through the State of North Carolina contract #070A, awarded on October 26, 2015, and effective through October 30, 2019.

N.C.G.S. 143-129(e)(9) authorizes "Purchases from contracts established by the State or any agency of the State, if the contractor is willing to extend to a political subdivision of the State the same or more favorable prices, terms, or conditions as established in the State contract."

It is recommended that a purchase order be awarded to Horace G. Ilderton, LLC, lowest responsive, responsible bidder for eight Dodge Journey, per bid specification, in the amount of \$17,524 each for the total amount of \$140,192. The purchase will be financed through the North Carolina Municipal Leasing Corporation. Funding for the lease payments is available in the General Fund Fiscal Year 2019-20 budget.
