- 3. 1756 Union Cross Road
- 4. 3044 North Patterson Avenue
- 5. 1344 Wentworth Road Accy Bldg.

## Local Historic Landmarks or Local Historic/Historic Overlay Districts

None of the buildings are Local Historic Landmarks or located within locallydesignated historic districts.

## **National Register Historic Districts**

Historic Resources staff has concerns about the loss of buildings in the City's National Register Historic Districts. Therefore, I have sent notice of this potential demolition to Preservation Forsyth, the local historic preservation non-profit organization. Their mission is to promote, protect, and advocate for Historic Resources in Forsyth County.

1) 1103 Sprague Street – Waughtown-Belview Historic District

The house at **1103 Sprague Street** is a ca. 1915 Bungalow. It is a one story; side gable; engaged porch with paneled square posts; vinyl siding; one-over-one replacement windows; gable dormer with two, four-light

If demolition for this structure is approved, Historic Resources staff requests that the Community Development Department have the structures professionally photo-documented and submit the photos to the Forsyth County Historic Resources Commission.
