- "The Durham Bicycle and Pedestrian Advisory Commission (BPAC) advises the Durham City Council and the County Commissioners on questions relating to bicycle and pedestrian issues.
- The Commission consists of 17 members with seven members appointed by the City Council representing citizens in subject areas such as Bicycle Commuting, NCCU Liaison, Recreation/Recreation Business, University Students/University Facilities, Urban Trails & Greenways, Transportation Planning Policy and At-Large.
- The monthly time commitment for a member is usually about 5 to 7 hours, including 2 hours per meeting. Additionally, most BPAC members participate on a subcommittee that meets monthly for approximately 2 hours."
- Asheville Bicycle & Pedestrian Task Force (<u>http://www.abptaskforce.org/index.htm</u>)
  - "The Asheville Bicycle/Pedestrian Task Force is a citizen's advisory committee to the city of Asheville. We work closely with city and metropolitan planning staff to give input on the needs of bicyclists and pedestrians."

  - "The purpose and scope of the activities of this Committee shall be the following: To advocate for programs that promote biking and walking and projects that provide safe and convenient facilities for bicyclists and pedestrians in Emerald Isle including the recommendations of the Highway 58 Corridor report. To form a visible, vocal and effective coalition of pedestrian and bicycle advocates. To support bicycle and pedestrian friendly legislation. To develop and implement bicycle and pedestrian safety education programs for bicyclists, pedestrians and drivers of motor vehicles. To advocate for bicycle and pedestrian friendly facilities throughout Emerald Isle including bicycle lanes and walkways and to promote livable communities and lifestyles by offering alternatives to automobile dependence."

  - Roadway projects to comment on bicycle/pedestrian accommodations
- Identify and assist in the implementation of bicycle and pedestrian programs related to education, encouragement, enforcement and evaluation efforts

Current Similar Committees and Roles:

- The MPO Bicycle & Pedestrian Committee has a limited role because the MPO is primarily limited to funding decisions. There is an important role for residents to play before projects are considered at the MPO level.
- The MPO Bicycle & Pedestrian Committee is responsible for the entire MPO area, making it difficult to focus on city-specific issues
- The MPO Bicycle & Pedestrian Committee has no official appointees and no formal processes, so it lacks a mandate and authority and does not represent the entire community.
- The Bicycle & Pedestrian Advisory Committee could draw from a larger pool of participants and better represent all interests
- The Bicycle & Pedestrian Advisory Committee would involve cyclists and pedestrians in an official capacity that is not accounted for otherwise

### Potential Formation and Operations

- Citizen-driven agendas and goals
- Approximately 9 members
- Citizen application to ensure residency
- Applications to Mayor's Office
- Terms
  - 2 members have 1-year term
  - 2 members have 2-year term
  - 3 members have 3-year term
- Reporting
  - Approved minutes are sent to City Secretary's office
  - Annual report of accomplishments
- Bicycle & Pedestrian Coordinator, DOT Director, and City Manager's Office representative serve as staff liaisons
