RESOLUTION AWARDING ON-CALL CONTRACT FOR PAVEMENT MARKINGS & SIGNS INSTALLATION

WHEREAS, the City of Winston-Salem has the need for an on-call contract to provide installation of pavement markings and signs on city streets which includes installation of thermoplastic lines of various widths, arrows, bike lane symbols, bike lane signs, various types of traffic signs, and removal of existing pavement marking lines; and

WHEREAS, after due advertisement, proposals were received by the City/County Purchasing Department at 12:00 p.m. on Tuesday, September 24, 2019 for an on-call contract to provide pavement markings and sign installations per bid specifications with one proposal offered from Alamance Striping and Equipment, LLC; and

WHEREAS, terms of the Request for Proposals (RFP) specified detailed criteria upon which each proposal received would be rated and an evaluation panel of City staff reviewed the proposal received to select the contractor most qualified to meet the requirements of the RFP, which are price value, experience, manpower commitment, business location, and commitment to the City's Minority/Women Business Enterprise (M/WBE) goals; and

WHEREAS, terms of the RFP allow the City the right to extend the contract for as many as four additional annual periods (until June 30, 2024), if both parties agree and funds are made available for that purpose, and unit prices may be adjusted at the beginning of each additional annual period by an amount not to exceed the latest available Consumer Price Index for All Urban Consumers; and

WHEREAS, it is recommended that an on-call contract to provide pavement markings and sign installations per bid specifications be awarded to Alamance Striping and Equipment, LLC,

the highest scoring proposer, in the estimated annual amount of \$250,000, and the total possible award over five years is the estimated amount of \$1,250,000; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Winston-Salem, that an on-call contract to provide pavement markings and sign installations per bid specifications is hereby awarded to Alamance Striping and Equipment, LLC, in the estimated annual amount of \$250,000 with the option to extend for four additional annual periods (until June 30, 2024), if both parties agree and funds are made available for that purpose, giving the contract a potential total value over five years of \$1,250,000, and that the City Manager and City Secretary are hereby authorized to execute the contract on behalf of the City with contract forms to be approved by the City Attorney.

BE IT FURTHER RESOLVED that the award of this contract constitutes a preliminary determination as to the qualification of the bidder. The City is not legally bound to perform the contract until the contract is duly executed by the City.

BE IT FURTHER RESOLVED that the 2019 LOBS for Pedestrian Safety Projects includes sufficient funds for this contract, with contract extensions based upon future funding availability.
