Summary of Information:

On June 9, 2020, HUD announced an additional award of ESG-CV2 funds to the City of Winston-Salem in the amount of \$2,047,257. During the month of July, the Community Development Department will issue a Request for Proposals to seek projects to use the ESG-CV2 and \$1,001,580 in CDBG-CV1 funds to assist persons experiencing homelessness and meet supportive housing needs in the community. The selection of programs and projects to be funded will be accomplished using the process established in the Governance Charter of the Winston-Salem/Forsyth County Continuum of Care (CoC), which is described more fully in Exhibit 1 - "Funding Process". Funding recommendations resulting from this process will be submitted to the Mayor and City Council for consideration.

Upon approval of the Mayor and City Council for the funding allocations, the City will prepare and submit to HUD a Substantial Amendment to the Consolidated Housing and Community Development Plan. Upon HUD's acceptance of the Substantial Amendment, HUD will issue a funding agreement to the City of Winston-Salem. Following its execution, agreements will be executed with agencies.

Previous Allocations of CARES Act Funding

On April 2, 2020, the U.S. Department of Housing and Urban Development (HUD) announced CARES Act funding allocations for Winston-Salem, including \$660,748 in ESG-CV1 funds and \$1,300,830 in CDBG-CV1 funds. On May 18, 2020, the Mayor and City Council approved a resolution authorizing acceptance of these CARES Act grant funds and execution of agreements with local agencies to provide services and assistance to homeless persons using a portion of the funds. A project budget ordinance also was approved to appropriate the funds. Agreements were executed with HUD for the funds on June 24, 2020.

To date, the \$660,748 in ESG-CV1 funds and \$299,250 of the CDBG-CV1 funds have been allocated to local agencies as shown below in Table 1. The process for determining allocations is described in Exhibit 1 - "Funding Process".

Additional Allocations of CARES Act Funding

In addition to the ESG-CV2 award from HUD, on June 15, 2020, the North Carolina Department of Health and Human Services published notice of an allocation of \$712,943 in non-entitlement NC ESG-CV1 funds for the Winston-Salem and Forsyth County area. The City of Winston-Salem is the collaborative applicant for local agencies for these funds.

On June 22, 2020, the North Carolina Department of Health and Human Services issued its Request for Applications (RFA) for NC ESG-CV1 funds and will accept requests for up to \$712,943 from Winston-Salem agencies. The state's RFA requests that Housing Stability activities, such as rapid re-housing and homelessness prevention be prioritized at 60% of funding. The balance of 40% in funds may be allocated to crisis response activities such as emergency shelter and street outreach.

The NC-ESG-CV1 applications are due to the state on July 17, 2020. The process described above, utilizing the CoC Rating Panel, Operating Cabinet and Commission on Ending Homelessness, will be used to select applications for submission to the state for funding consideration. A separate item is being submitted to City Council for action on it.

Table 2 below shows a projected allocation of NC-ESG-CV1 funding. The final amounts may vary after project selection, depending on applications received from local agencies and selected through the state's funding process. The project allocations shown will satisfy the state's requirement that at least 60% of funds are allocated to housing stability activities.

Additional Requirements

All projects selected for funding will be required to participate in the Homeless Management Information System (HMIS) which is required by HUD for projects assisting homeless persons. HMIS is used for performance measurement and reporting to HUD and the state.

Funding Priorities

The HUD funding programs have a number of eligible activities. Table 3 below shows the priority for use of funding from the available sources. The priorities are based on needs identified by Continuum of Care partner agencies and City staff. Prioritization to meet these needs is consistent with the CoC's Strategic Plan.

Funds are eligible to be used for both permanent housing and shelter activities. Permanent housing activities include Permanent Supportive Housing (PSH), rapid re-housing and homelessness prevention. Permanent Supportive Housing is housing with long-term services and assistance for homeless persons with disabilities. Rapid re-housing provides short- and/or medium-term financial assistance, accompanied by case management. Homelessness prevention provides financial assistance and supportive services to assist persons in avoiding homelessness.

Emergency shelter essential services includes services such as case management and housing search and placement assistance. Shelter operations includes costs to operate emergency shelter including maintenance, facility rent, security, fuel, equipment, insurance, utilities, food and furnishings. Where no appropriate emergency shelter is available for a homeless family or individual, eligible shelter operations costs may also include a hotel

or motel voucher for that family or individual. Funds also can be used for shelter renovation or to convert a building into an emergency shelter.

A summary of all CARES Act funding and other funding to address homelessness is provided in Exhibit 2.

Action Request

The accompanying resolution authorizes the City Manager to execute funding agreements with HUD, negotiate and execute agreements with agencies in the amount of funding determined through the Continuum of Care funding process, negotiate and execute agreements for participation in the Homeless Management Information System and submit periodic progress reports to HUD.

Exhibit 1

Funding Process

The selection of programs and projects to be funded will be accomplished using the process established in the Governance Charter of the Winston-Salem/Forsyth County Continuum of Care (CoC). Under this process, projects first are reviewed by the CoC Rating Panel, which develops funding recommendations. The second step is to present the funding recommendation to the CoC Operating Cabinet for comments. Next, the funding recommendations are presented to the Winston-Salem/Forsyth County Commission on Ending Homelessness for its approval of the funding recommendation, which is subject to approval of the City of Winston-Salem. Further description of these groups and the process are provided below.

The CoC Rating Panel is comprised of citizens appointed by the CoC Operating Cabinet in a process facilitated by the Community Development Department. Six of the seven current Rating Panel members are citizen volunteers recruited from the list of graduates of the City of Winston-Salem University. The seventh member, serving in an ex officio capacity, is the chair of the Continuum of Care. Rating Panel members serve three-year terms and select a chair and vice chair to serve one-year terms.

The Panel's funding recommendations are presented to the CoC Operating Cabinet for comments. The Operating Cabinet is elected by the CoC's general membership and is comprised of 36 representatives. Because the Operating Cabinet includes agencies that are funded with HUD funds or seeking funding, the Operating Cabinet reviews the funding recommendations and provide comments, but has no authority to approve or reject the funding recommendations.

After CoC Operating Cabinet review, the funding recommendation and any comments obtained are presented to the Winston-Salem/Forsyth County Commission on Ending Homelessness. The Commission is comprised of sixteen voting commissioners. Five commissioners are appointed by the City Council, upon the recommendation of the Mayor. Five commissioners are appointed by the County Commissioners. Five commissioners are nominated by the Operating Cabinet of the Continuum of Care and are subject to recommendation for appointment by the City. The Mayor and the Chairperson of the County Commissioners appoint the chairperson of the Commission. To avoid any conflicts of interest, no member of the Winston-Salem/Forsyth County Commission on Ending Homelessness may participate in or influence discussions or resulting decisions concerning the award of a grant or other financial benefits to an organization that the member represents as a staff person or board member.

The funding recommendations resulting from the CoC process are subject to approval of the City of Winston-Salem. Also, funding awards to agencies are subject to the City receiving awards of ESG-CV and CDBG-CV funds from HUD that are required to support the selected projects.
