Summary of Information:				
The City advertised bids for Cloverdale Avenue Pedestrian Improvements. This phase of the project entails work from Medical Center Blvd east to the Salem Parkway bridge overpass. The scope of work includes the following: milling and paving of approximately 200 linear feet of Cloverdale Avenue, installation of ten new curb ramps, three concrete islands, concrete sidewalk, and crosswalk pavement markings. Bids were received March 10, 2021, with the summary of bids as follows:

Remarks:				

The North Carolina Department of Transportation (NCDOT) established subcontracting goals for this project with a combined goal of 8% MWBE. The low bidder meeting bid specifications, Smith-Rowe, LLC, submitted subcontracting goals of 11.18% with minority and woman-owned businesses, exceeding the MWBE goal.

The funding for this project will consist of reimbursement to the City by NCDOT for up to one hundred percent (100%) of all eligible project costs under a two-party Construction Agreement; therefore, it is recommended that a contract be awarded to Smith-Rowe, LLC, the low bidder meeting specifications, in the total estimated amount of \$317,903.75. The engineer's estimate was \$351,176.

Award of this contract is contingent upon approval by NCDOT, who will review the City's award recommendation. Prime bidders and M/WBE subcontractors must be pre-qualified with NCDOT at the time the bids are opened.

M/WBE comment: This project was advertised on the City and State Purchasing websites, HUB websites, Winston-Salem Journal, with several electronic plan rooms, and 42 general contractors were notified directly of this opportunity. Notifications were also sent to all local M/WBE and regional HUB and DBE businesses. See Exhibit A for a complete list of businesses that were notified the bidding opportunity and the low bidder's Workplace Demographics form.
