Mayor Pro Tempore Burke said to be careful about people taking advantage and offering to help when they just want money. She said to be very cautious.

Police Attorney Sykes said we cannot destroy weapons. We may be able to look at a way to switch out weapons for other needed items.

Mr. Al Andrews, Assistant City Attorney presented a powerpoint to Council regarding the Citizen Police Complaints and Actions Process.

Council Member MacIntosh asked if this will be an online process? Yes He said we would be headed in the front edge of things. If we hire a contractor, would we own the process? Assistant City Attorney Andrews said we could explore or share.

Council Member Larson asked how many portels do we have, chat lines? We will still need some hierarchy on what a citizen complains about. If you don not have a computer or Iphone, you will still have the ones who call directly, call the council or chief.

Mayor Pro Tempore Burke asked if we get a lot of complaints, Assistant City Attorney said we do not have a lot of them. At one time, we did not have anyone to take complaints and police officers did not get along. The Citizen Police Board came out of this, the citizens are on the Board so they hear and make decisions and have a say so. We need to remember that police are people too.

Chair Taylor said the consensus is not to give up a persons way of making complaints.

How much was allocated for this project (\$62,000). We do need the people to feel safe and tourism is important in this area.

Chief James Taylor said there are plenty of other areas needing cameras.

Tasha Ford, Assistant City Manager said there is some money to purchase cameras. There are some areas needing them due to high crime.

Mayor Pro Tempore Burke asked how long will cameras stay in a location, if you take them away, crime will return.

Council Member Larson said we have two different types of cameras and we do need cameras for high population events. We look forward to seeing a hard proposal for this.
