**G-4.** Update on Preparations for 2021 Carolina Classic Fair. (North Ward)

Ben Rowe, Assistant City Manager, provided the staff report for this item.

Dr. Christopher Ohl, Wake Forest Baptist Medical Center Infectious Disease Expert, recommended moving forward with the fair with precautions put in place.

Joshua Swift, Forsyth County Public Health Director, echoed Dr. Ohl's thoughts that the fair would be low-risk for spreading COVID-19 because it is mainly outdoors.

Council Member Mundy recommended having a vaccine clinic at the fair, as well as having citizens agree to all guidelines, including wearing a mask, before they are allowed to buy tickets electronically.

Council Member MacIntosh noted his concerns of having a large amount of people gathered for the fair, as well as the carnival workers not be tested for COVID-19 or wearing masks.

Council Member Burke requested historical data of children 12 and under attending the fair, as there is no vaccine currently available to them.

Council Member Clark noted his agreement that this is a good plan and that people who don't feel comfortable with going to the fair shouldn't go.

Council Member Scippio clarified that masks would only be required indoors, but strongly encouraged outdoors.

Mr. Rowe noted that this was just a recommendation from staff, but changes could be made to the plan at Council's request.

Council Member Mundy requested staff look in to if any studies had been done on the COVID-19 rates of communities that had already held fairs.

Minutes

Mayor Pro Tempore Adams stated that she doesn't want the fair to happen this year, as the COVID-19 numbers are rising, especially between young people and children.

Council Member Mundy asked if requiring proof of vaccination to get in to the fair had been thought of as an option. He also stated that he wanted to hear directly from Chief Thompson on if she thought the fair was a good idea or not.

Rich Newnum, Police Captain, stated that we need to be cognizant of the Police's ability to effectively keep youth from being close together during the fair.

Lee Garrity, City Manager, noted that the Police Department is very short staffed and the fair would have a lower staffing level than in previous years.

Council Member Scippio invited everyone to visit the new exhibit at the Forsyth Central Library, Undesign the Red Line.

There being no further business to come before the Committee, the meeting adjourned at 5:49 p.m.
