Council Member Larson asked about the process for distribution of this property for development. He also asked about the process for creating affordable housing from the current properties owned by the City.

Council Member MacIntosh agreed that we need to have a defined housing policy and that we should put out requests for proposals for creative designs and ideas to satisfy the neighborhood while creating affordable housing.

Mayor Pro Tempore Adams suggested a housing summit.

Mayor Joines suggested having staff dedicated to working on the City's affordable housing.

Council Member Larson requested a comprehensive list of City properties that are currently buildable. He also requested staff to note which properties had the potential for more than one building.

Council Member Taylor said that a similar item was proposed 10 years ago and the neighbors made it clear that they did not want it.

*Council Member Clark suggested we find developers who are interested in partnering with us for affordable housing before buying the property.*
